**Cost**

Cost will not be prorated nor will the cost be reduced for multiple banners. Banner placement is at the discretion of the TOES PTO and placement requests are not accepted. **Acceptable AD Formats**

Each banner is vinyl and will measure approximately 3 feet high by 5 feet wide. Each banner will have an appropriate number of grommets to attach to the car loop fence.

Ad artwork is acceptable in AI, PDF, PNG or JPG formats, though VECTOR is preferred.
